The development efforts carried out by increasing the intensity of traffic education and legal counseling and human resource development.

Preventive measures through improved supervision of roadworthiness, vehicle and road infrastructure, as well as the worthiness of vehicles, including in the areas of traffic control and road transport more intensively. Efforts arrangement includes management and traffic engineering and modernization of traffic infrastructure. Law enforcement efforts implemented more effectively through the formulation of legal provisions clearer and firmer sanctions.

To deal with traffic accidents, accident prevention is done through stakeholder participation, community development, law 5 forcement, and global partnerships [5]. Prevention of traffic accidents is, the normal pattern of phasing, the program short term, medium 5 m and long term. In addition, to draw up accident prevention program conducted by the forum traffic and road transport [6].

In connection with the duties and authority of civil servant investigators (investigators) the field of traffic and road transport, the legislation already stipulates that in order to carry out its duties and functions investigators to always coordinate with the Indonesian National Police as coordinator and supervisor of the investigator civil servants [7] [8]. It is intended to prevent overlapping authority and the rule of law as stipulated in the laws and regulations, including laws on the Criminal Code (Criminal Code).

The setting and the application of criminal sanctions shall be decisive. For the offense to its light weight, penalized imprisonment or a fine which is relatively mild. However, the gross violations and there is the element of intent subject to criminal sanctions are much more severe. It is intended to be a deterrent effect for offenders with fewer burdens on society. In addition to criminal penalties, also arranged on administrative sanctions imposed on transport companies in the form of warnings, license suspension, revocation, giving fines. Provisions concerning criminal and administrative sanctions threatened also to officials or organizers of the street [9] [10]. On the other hand, in order to improve the effectiveness of law enforcement applied system of reward and punishment (reward and punishment) in the form of incentives for officers who excel.

This study aims to: 1) know the efforts to optimize the prevention of traffic accidents in Bojonegoro 2) determine the cause of traffic accidents in Bojonegoro Regency.

From some of the above table are taken from the data unit traffic accident in Bojonegoro Regency, the writer conclude that from the 2010-2014 crash in Bojonegoro Regency occurred 576 cases. Each year has increased and most of the victims suffered minor injuries. According to the Head of the Traffic Police of Bojonegoro, accidents that occurred in Bojonegoro most experienced private sector employees who reached 164 cases. In general, they do not conduct or violating traffic signs. It was in because they chase the time to enter the office (late entry office). In addition, also, a factor also affecting the road traffic accident in Bojonegoro. There are many roads are damaged

(holes or bumpy). According to the Head of Traffic Unit Bojonegoro to minimize the occurrence of accidents or the impact of the accident, it helps the driver to pay attention to the following the following: use of a seat belt (seat belt), Maintenance (maintenance), Road Design, Road User Rule.

### 2) Efforts to Optimize Prevention of Traffic Accidents in Bojonegoro

Given the frequent occurrence of traffic accidents, and therefore if it is to cope with the traffic accident in a comprehensive manner so as to anticipate the factors contributory to the problem of traffic accidents completely, we need a prevention efforts that include engineering infrastructure and means of traffic (engineering), coaching elements of road users (education), as well as engineering in

the field of law or regulation, including law enforcement (enforcement).

From interviews with the writer of Head of Traffic Police of Bojonegoro, efforts have been made by the police in dealing with traffic accidents is as follows:

- Efforts pre-emptive (deterrence), preemptive efforts as an antidote in tackling traffic accident, basically covering engineering various fields related to transportation issues, so as to eliminate the early impacts that might arise. Pre-emptive effort in tackling traffic accident can be implemented through integrated action in:
  - Setting the development along the side of the road;
  - Land use planning that minimizes conflict between traffic with pedestrians and reduces the need to travel;
  - c. Planning the development of transport;
  - d. Civilizing traffic discipline.
- 2. Preventive efforts (prevention), directed to secure the potential conditions for the occurrence of accidents. Preventive efforts are efforts aimed at preventing the occurrence of traffic accidents, which is in the form of concrete activities such as traffic management, maintenance-prone areas, patrols and escorts. Given that traffic accidents occur due to human factors, vehicle, road and environment simultaneously, prevention can be directed to the setting-component component of traffic and traffic systems.

Repressive measure (reduction), in the

form of legal action against any form of violation of traffic accident cases.

Essentially repressive measure in order to protect the traffic accident is a late effort which is usually accompanied by the effort of applying force. Repressive actions carried out against any type of traffic violation or violations in the form of traffic accident cases. Traffic enforcement as a form of repressive effort was made to any road users violating traffic laws and road transport, if the educative measures undertaken by the efforts of preemptive and preventive can not cope with the problem.

Law enforcement is carried out effectively and intensively, in its essence is not solely intended to provide a lesson by force or to punish any offenders to the oppressed, but also aimed at creating abundance for the relevant order not to repeat the act again. Thus any repressive action also contains preventive elements. In connection with the repressive efforts of this, we need to realize together that the success of efforts to control traffic safety through prosecution can not depend only on the activity of law enforcement agencies

alone, but must be considered as well as other factors such as road users are disciplined and obey all applicable regulations are very affect the success of law enforcement. Besides the quality of its officers, law enforcement will only be effective when supported by other factors, such as the gear means to enforce the law, the effectiveness of the law itself and the level of public awareness.

#### 4. Conclusion
